ORDER

New Delhi, the 29th September, 2022

S.O. 4608 (E).—In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian Standards is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following order to amend the Synthetic Micro-Fibres for use in Cement Based Matrix (Quality Control) Order, 2022, namely:—

1. Short title and commencement. – (1) This order may be called the Synthetic Micro-Fibres for use in Cement Based Matrix (Quality Control) Amendment Order, 2022.

(2) It shall come into force on the date of its publication in the official Gazette.

2. In the Synthetic Micro-Fibres for use in Cement Based Matrix (Quality Control) Order, 2022 (hereinafter referred to as the said Order), in paragraph 1, for sub-paragraph (2), the following sub-paragraph shall be substituted, namely:—

“(2) It shall come into force on the 3rd day of April, 2023.”

3. In the said Order, after paragraph 4, for the TABLE, the following TABLE shall be substituted, namely:—

Note : For the purposes of the TABLE, the latest version of the Indian Standards including the amendments issued thereof, as may be notified by the Bureau of Indian Standards from time to time, shall apply from the date of such notification”.
